B. ACADEMIC HISTORY

6. A. Research Endeavours

I am engaged in research that brings together three fields of inquiry:

- 1) Investigation of contemporary Latin American and Spanish film, literature, and politics. This is evidenced in the courses that I teach and in my new book project, which is a novel based on research into Spanish cultural memory, environmental degradation, and political engagement.
- 2) Theoretical engagement with the attention economy, in particular with questions of relationality, queer and affect theory, and environmental humanities. This is evidenced by my book, *Take Her, She's Yours*, which interrogates possessive individualism, psychoanalysis, gender, sex, and power; by the J.H.L. Priestley Prize for my essay on relationality; and my article in *Public* on attention deficit.

- 3) Meta-analysis of the state of the discipline, and of the genres and forms that the academy uses to disseminate its research. My work in this field is evidenced not only by my own experiments in writing creatively, but also by:
 - a. The Toronto Humanities at Large Workshop, an initiative that I cofounded in 2016 with the support of the Jackman Humanities Institute in order to train academics to reach wider audiences through their writing.
 - b. Banff Research in Culture, a residency at the Banff Centre for Arts and Creativity that I co-organized. BRiC brought together researchers, activists, visual artists, and scholars around a common theme, affording academics a way of collaborating and discussing their work with people outside of their discipline.
 - c. My pedagogy and writing about the genre of academic writing and the state of the discipline, as evidenced by my book chapter, "Pedagogy, Writing, and the Future of Comparative Literature," which functions as a forum for five leading scholars to respond in a subsequent chapter. I am dedicated to expanding the role of the dissertation, and am on the SGS Working Group on the Dissertation, and the Research Creation Project PhD committee in Comparative Literature. I regularly teach, at the graduate and undergraduate level, courses in experimental Critical Writing.
